- **Access to Justice:** Small and medium-sized enterprises often lack the resources for legal representation, emphasizing the need for accessible legal clinics and advisory services.
- **Transparency and Corruption:** Persistent issues of transparency and corruption erode trust and efficiency within the legal system.
